

TERMS OF RENTAL - ACCOMMODATIONS

CAMPING DE LA MOTTE

RESERVATION : the booking will be effective only after the return of the completed rental contract dated and signed, and after receipt of a deposit equivalent to 30% of the total price of the stay. Upon receipt of the deposit within 14 days after sending the documents, any reservation is final. Any modification of the contract before the reception of the deposit must be indicated beforehand and will be possible only with agreement of the camping.

In the case of a reservation that takes place less than 30 days before the arrival date, payment in full will be requested at the time of booking. Only local tax will be paid on arrival.

PAYMENT OF THE BALANCE OF THE STAY : the balance of the stay is payable 30 days before the day of the arrival. No reduction will be granted in case of delayed arrival or early departure. The balance to be paid corresponds to the tariff on the contract. Only the visitor's tax will be paid on the spot on the day of your arrival.

No reduction will be applied if the number of persons present is less than the number of persons mentioned in the contract; however, if the number of persons present exceeds the number of persons mentioned in the contract, a supplement will be charged according to our rates in force.

Our prices are inclusive of VAT; the VAT is applicable according to the rates in force.

CAUTIONS : A deposit of 200 € for the accommodation and 50 € for the cleaning in separate check and for each accommodation will be paid by the tenant the same day of his arrival. These will be returned upon departure, provided that the accommodation is returned in the same state of cleanliness as on arrival, complete and in good condition. In case of early or late departure, the deposit is returned within 8 days, subject to possible deductions for cleaning or repairs. Such a departure is tantamount to an acceptance of the decision on the possible deduction of all or part of the security. The deposit of 50 € will be retained if the accommodation has not been cleaned properly before departure.

INVENTORY : The equipment of each lodging is the subject of an inventory given to the tenant who is required to check it on arrival and to report any anomaly. The tenant must deliver the duly signed inventory form to the reception on the day of arrival. Any form not rendered implies acceptance by the tenant (the signing of the rental contract is proof); No complaint will be possible without signed form of state of the place. The departure inventory will be carried out by the camping staff on the day of departure.

RENT : The prices of the hirings are all expenses including water, gas and electricity charges. In addition: city tax. Rates include VAT; The VAT is applicable according to the rates in force.

In the case of pricing spread over 2 periods, the tariff will be calculated in proportion to the tariffs corresponding to each of the periods.

ACCOMMODATION : For security and insurance reasons, it is strictly forbidden to exceed the number of occupants provided in each rental. The equipment that you will find at your disposal in the rentals corresponds to the number of people who can stay there. Bed linen, kitchen and bathroom linen and cleaning products are not provided. The rentals are strictly non-smoking.

DATE AND STAY : The stays start from 3 pm on the day of arrival and end at 10 am on the day of departure. We ask that you respect these schedules.

Arrivals are until 8 pm: after this time, the tenant will have to notify us.

If the tenant does not show up on the day mentioned on the contract without informing the campsite, the rental will remain at his disposal for 24 hours; After this time we can re-dispose of the rental and the deposit paid will remain vested.

PROCEDURE RULES : The signing of this rental contract also constitutes acceptance of the campsite's internal regulations, which can be downloaded from our website: www.camping-vendee-lamotte.com.

CANCELLATION : Any cancellation must be received by mail or by mail, the date of receipt being proof.

If you do not opt for cancellation insurance, in the event of cancellation of your stay, the entire deposit will be withheld unless cancellation takes place more than 30 days before the start of the holiday. Stay, in the following cases and on proof :

- illness, hospitalization, accident of persons mentioned in the contract

- death of the persons mentioned in the contract, spouse, cohabitant, ascendant, descendant, brothers and sisters.

Any reservation canceled less than 30 days before the arrival date will not give rise to any refund of the deposit. An interruption of stay will not give rise to any refund, for whatever reason.

To obtain a refund in the event of cancellation or interruption of stay, we invite you to take out cancellation insurance upon signing your rental agreement, effective with our partner Campez Couvert.

INSURANCE : We decline all responsibility in case of loss or theft of objects, as well as deterioration inside the hirings: we strongly advise you to check that your liability insurance covers well the incidents that may occur during your stay.

AUTHORIZATION OF DIFFUSION : We may be required to take a picture to illustrate our website or our advertising brochures ... If you do not wish, you will have to notify by registered mail before your arrival.

VISITORS : Visitors should arrive at the reception desk; They will pay the fee and they will have to respect the rules of procedure. Their vehicle will be parked in the parking lot at the entrance. Any undeclared visitor will be charged at the rate of one additional person. Access to the swimming pool is forbidden to any visitor.

ANIMALS : Pets are not allowed in our hirings.

SECURITY : The pond of the campsite is fenced and closed with a gate. No child shall enter without unaccompanied adult. Panels installed around the pond remind you. In the event of an incident, the campsite discharges itself of all responsibility.

Children not able to swim and not accompanied by an adult should not enter the pool area alone.
